1934-1938: The main RA group in the ward was the Harrow Weald Ratepayers' Association.

1934: Telfer also received support from the Hatch End Association.

1934-1939: Ousey was supported by the Hatch End Association.

1935: Mennell forfeited the support of the Harrow Weald Ratepayers' Association due to his support for the Kynaston Court Civic Centre plan.

Sparkes stood for election as a 'United Front Workers' candidate. He retired on the eve of poll on learning that the Labour Party was pledged to fight for abolition of Part II of the Unemployment Act.

1945: (21/4) On a show of hands the Council co-opted Leigh in preference to Knowler by 19 votes to 12.
