1982: Davenport and Knight were the candidates of the Roxbourne Ratepayers' Association.

1987: Bartrick resigned from the Council on 1 December 1986 after he had been served by a Notice of Motion in the Divisional Court of the Queen's Bench Division of the High Court of Justice. The proceedings were commenced by the local Conservative Party through one local government elector (Jennifer M. Nutt) after the local press had revealed that Bartrick was under-age (20 years old) at the time of both his nomination and election.
