**Note:**

- 1986: Subsequent to the election Wilson adopted his wife's surname of Woodrow upon their marriage.
- 1994: Crossman resigned from the Liberal Democrats in August 1995 and announced that he would sit as an Independent. In September 1996 Crossman became the prospective Parliamentary candidate for the Referendum Party in Harrow West. In November 1997 Crossman formed "The Constituents' Party" with Cllr. Tuck (Pinner West); but this grouping was dissolved in March 1998 when Crossman joined the Conservative Party.
- 1996: This by-election was due to be held on 23 November 1995 but was countermanded (as required by the Local Elections (Principal Areas) Rules 1986) on 21 November following the sudden death, after nomination, of Liberal Democrat candidate Norman Simmons.
- 1997: Mrs. Warwick was a former member of the Conservative Party. She acted as Agent for the Referendum Party in Harrow West at the General Election.
