Note:

- 1978: Taylor campaigned for improved nursery education.
Short resigned from the Labour Party and joined the Liberal Party in October 1981.
- 1979: A Liberal Party member, Brian J. Cannon, had been selected to contest the by-election, but his nomination papers were not submitted in time.
Tidmarsh resigned from the Labour Party in April 1981 following his failure to be nominated to the Harrow Labour Party Panel of Candidates for the 1982 election. He announced that he would sit as an Independent, but shortly afterwards joined the Social Democratic Party.
- 1982: Hand was expelled from the Council's Conservative Group in December 1984 because of his poor record of attendance at Council meetings.
- 1986: Shah had been a prominent member of the local Liberal Party until his resignation a few months before the election.
