Note:

1978: On 23 May 1978 an election petition was lodged, asking for the election of Heaton to be declared void and for K. Underwood to be declared elected in his place. See Appendix J for details.

Forder and Woods were the candidates of the Roxbourne Ratepayers' Association.

G. Davies, a former Labour Councillor for Roxbourne, sought election as a "Roxbourne Residents and Tenants" candidate. He called for the introduction of a Tenants' Charter.

Bolton and Warshaw sought election as independent "Roxbourne Ratepayer" candidates. They told the *Harrow Observer* that they were contesting the election in "total opposition to the irresponsible actions of the Roxbourne Ratepayers' Association". They were opposed to the use of the Association's general fund (rather than a special election fund) to finance the election and protested that both Association candidates did not live in Roxbourne ward.

Warshaw was a former Labour Councillor and at the time of the election a member of both the Roxbourne Ratepayers' Association and Roxbourne Labour Party. Bolton was a member of neither organisation but was well-known in the area as a Socialist. He had been a Labour Party candidate for the Stanmore North ward in 1963.

1978: (7/9) The election of Heaton was declared void as a result of the hearing of an election petition in the Queen's Bench Division of the High Court of Justice on 20 July 1978. Further details may be found in Appendix J. Papers relating to the petition and hearing are available at the National Archives, reference J104/610.

Woods was the candidate of the Roxbourne Ratepayers' Association.

Hixon had previously contested elections as an "Independent Conservative" candidate.

1982: Bull and Pillman were the candidates of the Roxbourne Ratepayers' Association.

1985: Mrs. Steele, who had been seriously ill, was disqualified from sitting on the Council under the terms of the Local Government Act 1972 for her failure, throughout a period of six consecutive months, to attend any meetings of the Council or its committees or sub-committees.
