Note: There were 3,445 local government electors on the *Register* in the North-East (H) polling district and 2,117 in the South-West (I) polling district. However both the *Harrow Gazette* and *Harrow Observer* reported that the number of electors at this election was 5,563. Turnout has been calculated on the basis that the reported number voting by both newspapers (1,626) is correct.

Frederick C. Pike had been the secretary of the local branch of the NFDSS. He described himself as the 'Independent Soldier Candidate'. His nomination papers had been signed by Otto H. Pike, one of the official NFDSS candidates.

W.H. Taylor and How tied for the twelfth elected place, each polling 433 votes. The Returning Officer (Richard J. Bryant) was entitled to use a casting vote but declined to do so. Taylor was declared elected after lots were drawn from a hat.

Of polling day, the *Harrow Observer* commented: "There was little excitement in the district, few carriages, one or two favours were exhibited and election cards thrown about, but there was nothing to denote that an exciting and important election was in progress beyond the candidates and 'persuaders' at the doors of the polling stations at High Street schools and the Bridge schools."

Collard, Twinn and Higgs sought election on a joint 'ticket'.

Both Mitchell and Lockwood were short-listed by Wealdstone Labour Party as potential candidates for this election. Mitchell then withdrew and stated that for business reasons he could not run on the Labour Party 'ticket', and would stand as an Independent instead.

Lockwood also withdrew, resigned from the Labour Party and contested the election on a joint platform with Mitchell. During the campaign Mitchell and Lockwood were supported by the Wealdstone (Wesleyan) Brotherhood. After the election Mitchell was expelled from the Labour Party together with three other members who had assisted his campaign.

The local press did not disclose the number of electors at this election. The Autumn 1925 *Register of Electors* for the Harrow Parliamentary division is not available at the London Metropolitan Archives; therefore the above electorate figure has been compiled from the Spring 1925 *Register*. It is likely to be an underestimate of the electorate at the 1926 election.

Rose was honorary General Secretary of the Wealdstone (Wesleyan) Brotherhood, and was in receipt of their support. Rose described himself as an "Independent Progressive" candidate and (despite signing Meller's nomination papers as his proposer) urged electors to 'plump' (i.e. use one vote only) for him.

The Kenton branch of the local Conservative Association actively supported the Ratepayer Association candidates, who (apart from Wale) lived in Kenton. The *Harrow Observer and Gazette* noted that the Conservatives were responsible for "a large fleet of cars, estimated at about 30, that toured the district carrying voters to the poll."

A meeting of Wealdstone Labour Party, held on 27 February 1929, agreed to adopt a recommendation from their Executive Committee (EC) that this election should not be contested. The recommendation, carried at the EC by 8 votes to 7, was prompted by the expectation that there would be local elections later in 1929 following the reorganisation of local government in the Harrow area.

The total number of electors and turnout (3,122 voting) shown above were reported by the *Harrow Observer and Gazette*. A *Special Report* presented to the Middlesex County Council in 1932 showed the total electors as 10,717 (29.1% turnout based on 3,122 voting).

Cook was General Secretary of the Miners' Federation of Great Britain from 1924 until his death from cancer, at the age of 47, in November 1931. His period of office included the General Strike of 1926 about which Cook wrote the pamphlet *The Nine Days*. This led to him being associated with the slogan 'Not a penny off the pay, not a minute on the day'. He lived in Carlton Avenue, Kenton.

The total number of electors was determined by a contemporary examination of the 1931 *Register of Electors*. The *Harrow Observer and Gazette* reported there were 13,849 electors and that 2,270 voted; the latter figure is assumed to be accurate and has been used in the 'percentage' calculations. A *Special Report* presented to the Middlesex County Council in 1932 tabulated the total electors as 13,959 (16.3% turnout based on 2,270 voting).

The *Harrow Observer and Gazette* reported that there were 14,664 electors on the *Register*. Turnout has been calculated on the basis of their report that 1,985 voted.

The local branches of the Labour Party and Co-operative Party had made an agreement to contest this election on a joint 'ticket', with three candidates coming from the Labour Party and one candidate from the Co-operative Party's membership. When the Co-operative Party failed to supply a nominee a decision was taken to continue with the candidatures of Gange, Barrow and Cullington using the 'Labour and Co-operative' description.

The Ratepayer Association candidates received support from the local Conservative Association.
