‡ Some important records for Great Stanmore have not yet been found, so the compilation of a comprehensive record of Chairmen and Vice-Chairmen is currently restricted to the periods 1895-1914 and 1925-1934.

In a *Kelly's Directory* printed for the 1923 calendar year Bransgrove is recorded as the Chairman and Kirby as the Vice-Chairman of the Parish Council. Bransgrove has also been described as the Chairman of the Council in some local newspaper articles from 1919, 1920 and 1922.

† Dr. Alexander Findlater of 'North Lodge' was elected Chairman of the Parish Council at the 1897 and 1898 Annual Meetings. He was a physician, Justice of the Peace and a prominent parishioner but was not a parish councillor.

‡ Cliff retired as a parish councillor at the 1910 election but was elected Chairman at successive Annual Meetings between 1910 and 1918. (He was an elected parish councillor for Edgware 1910-13.)

¶ Resigned October 1910. P.P. Sechiari elected Vice-Chairman December 1910.

§ Resigned October 1913. P.P. Sechiari elected Vice-Chairman December 1913.

** The Rev. Daniel Tatton of 'Moorlands' was a Congregational minister and prominent parishioner but not a parish councillor. He was elected Chairman of the Parish Council at successive Annual Meetings between 1919 and 1923. He resigned in June 1923; the Rev. C.W. Scott-Moncrieff was elected Chairman.

* Charles G. Kekewich of Barnet Lane, Elstree, was elected Chairman of the Parish Council at its first meeting in December 1894, and at the 1895, 1896 and 1897 Annual Meetings. Although he was a prominent parishioner he was not a parish councillor.

† Elected Chairman of the Parish Council at the 1901 and 1902 Annual Meetings although not a parish councillor.

‡ The Reverend James Goggin of Church House, Garratt Road was a Roman Catholic priest who was elected Chairman of the Parish Council at the 1922 and 1923 Annual Meetings. Goggin was not a parish councillor. He resigned in June 1923 due to poor health; G.R. Mann was elected as his replacement.

¶ Elected Chairman June 1923. D.E. Erlebach elected Vice-Chairman.

§ Resigned September 1928. W.H. Purchase elected Vice-Chairman November 1928.

According to the Minutes of the Council, no Vice-Chairman was elected at the Annual Meetings in 1897 or 1909. During the 1897-98 Municipal Year different councillors took the chair when Kekewich was unavailable. In the latter case (1909-10 Municipal Year) it may have been an oversight by the clerk when writing the Minutes and that Wainwright was elected to continue as Vice-Chairman.
