

## Appendix V

### NEW WARD STRUCTURE FOR THE 2022 BOROUGH ELECTION

In July 2018 the Local Government Boundary Commission for England (LGBCE) began a three-year programme of electoral reviews of the 25 London Boroughs that it not reviewed during the previous five years. The last review of Harrow's ward boundaries had taken place in 1998-9: the borough was therefore included in the group of 25 boroughs to be reviewed. The aim of the electoral reviews was to "recommend ward boundaries that mean each councillor represents approximately the same number of voters" and "to ensure that the ward boundaries reflect the interests and identities of local communities, as well as promoting effective local government." Consideration of borough boundaries (with neighbouring local authorities) and Parliamentary constituency boundaries formed no part of the reviews.

The Commission (having received submissions from both the local Labour and Conservative Parties) had decided by 24 July 2018 that Harrow should in future be represented by 55 councillors, a reduction of eight from the previous arrangement with 63 councillors. The review of warding arrangements commenced on 31 July and lasted until 8 October 2018. On 4 December the LGBCE published their draft proposals, recommending that Harrow should have 22 wards (one more than previously) and that there should be a mix of three- and two-member wards. Consultation on the draft proposals lasted until 11 February 2019. The LGBCE announced in March 2019 that it had entered a period of further limited consultation on amended draft proposals in the Harrow Weald and Wealdstone area; this lasted from 2 April to 29 April 2019.

The LGBCE published their final recommendations on 28 May 2019 and the London Borough of Harrow (Electoral Changes) Order 2020 (S.I. 2020/72) was published on 28 January 2020. A summary of the outcome of the review is tabulated below. The electors figures relate to the number of local government electors in each of the new wards in 2018 together with a forecast for 2024 (using figures supplied to the Commission by Harrow Council).
