Note:

- 2002: Williams resigned from the Council's Conservative Group in January 2003 to sit as an Independent. He described the Group as "divided and shambolic" and added that as a practising Christian he was "finding it increasingly difficult to reconcile the machinations of Harrow Conservative Group with the teachings in Holy Scripture". Williams supported Labour Group Budget and Council Tax proposals until he retired from the Council in May 2006.
- 2018: In October 2020 Chana was suspended from the Council's Conservative Group for a period of six months while the Party investigated his conduct. A hearing at Bristol Employment Tribunal in September 2020 concluded Chana had been responsible for harassment of a work colleague that included making a series of Islamophobic comments. The case was brought against Dyson Technology Ltd by a former member of staff who had resigned from her post in June 2018; the Tribunal found that she had been constructively dismissed. Chana was reinstated in the Conservative Group in April 2021.
