Note: Turnout has been calculated on the assumption that the number voting (638), reported by both the *Harrow and Wealdstone Press* and the *Watford Observer*, is accurate and that the figure given (600) by the *Harrow Gazette* is an estimation. The *Watford Observer* overestimated the number of electors as 1,200.

Short and Dunmore were the candidates of the Harrow Progressive Union and called on "Working Men and Women to Vote for your Working Class Candidates" and to "rally round the cause of Labour and to vote for their fellow workers". A seventeenth candidate for this election and the Union's intended third candidate, Henry Godfrey, withdrew after the close of nominations but within the allowable period.

An eighteenth candidate for this election, Dr. Edward W.F. Stiven, withdrew after the close of nominations but within the allowable period.

The *Middlesex and Buckinghamshire Advertiser* reported on polling day as follows: "Polling ... took place on Monday last at the Harrow Board School, Roxeth Hill, Mr. R.E.H. Fisher being the Returning Officer. All the arrangements for the poll were satisfactorily made, and no hitch of any kind occurred throughout the day. The day was very dull and it rained, little or much, the whole day. This had a most depressing effect, and kept many away from the poll, especially the Greenhill voters, who bitterly complained that a polling place had not been [arranged] in their district.... After the poll had closed at eight o'clock, the officers adjourned for an hour for refreshments and then commenced their weary task. This was accomplished most expeditiously and at 11.30 the poll was declared."

Additional reporting was supplied by the *Watford Observer*. "The results of the elections throughout the whole of the old Parish of Pinner, with the exception, perhaps, of Harrow-on-the-Hill itself, have given much satisfaction. A radical change has taken place at Harrow, the old Board, with one exception, being replaced by strangers..... The polling stations were at the Board Schools. Mr. J.L. Winckley presided over No. 1 Station, and Mr. A.C. Fisher over No. 2. The polling was very steady and there was little excitement."

At the first meeting of Harrow-on-the-Hill UDC on 3 January 1895, the Clerk submitted his account of expenses incurred as Returning Officer for this election, amounting to £25.6s.4d.

The *Minutes* of the meeting of the Council held on 26 May 1896 record that Smith agreed to postpone his resignation "until 6 months before the 15 April next so that the necessity of another election would be avoided."

Note: On 1 October 1895 Local Government Board Order no. 33,399 made radical changes to the boundary of Harrow-on-the-Hill UD with Wealdstone UD. This was the first election following the Order coming into force; 156 parochial electors (1896 *Register*) transferred to Harrow-on-the-Hill, while 4 parochial electors transferred to Wealdstone.

The *Harrow and Wembley Observer* reported that “only one half of the electors took the trouble to record their votes” and that the election had been “exceedingly unexciting and uninteresting”. The *Harrow Gazette* also did not give an accurate turnout figure, only remarking that by 6 pm on polling day less than 300 electors had voted.

The *Middlesex and Buckinghamshire Advertiser* remarked that, after the result was declared, “Messrs. Webb and Hawkins adjourned to the Liberal Club, and each made a speech to the crowd of members who had gathered together to congratulate them.”

At the meeting of Harrow-on-the-Hill UDC on 13 April 1896, the Clerk submitted his account of expenses incurred as Returning Officer for this election, amounting to £34.6s.9d.

Barret called for the district of Greenhill to be made into a separate electoral ward of the urban district.

The *Harrow Gazette* incorrectly reported that the number of electors at this election was 1,624. Turnout has been calculated on the basis that the reported number voting (817) is accurate, a figure confirmed by the *Middlesex and Buckinghamshire Advertiser*.

Lascelles was the Librarian at Harrow School. The previous year he had contributed two chapters (on 'Early Headmasters' and 'Speech Day') to the book *Harrow School*, edited by E.W. Howson and G.T. Warner (Edward Arnold, London, 1898, pp. 54, 199). Lascelles served continuously as a councillor (and later also as a county councillor) until his death, in January 1922, at the age of 62. H.M. Wilkins (in his 1976 booklet *The Wealdstone Scene: The Story of Harrow's Victorian Neighbour*, p. 71) reports that Lascelles was a giant of a man who "stood six feet ten inches tall".

The *Harrow Gazette* incorrectly reported that the number of electors at this election was 1,680. Turnout has been calculated on the basis that the reported number voting (749) is accurate, a figure confirmed by the *Middlesex and Buckinghamshire Advertiser*.

The *Advertiser* stated that Young was "the Advocate for Workmen's Dwellings". Two days following the election he took the Chair at a crowded "Grand Smoking Concert" organised by the Liberal Club in the large Lecture Hall. Young was supported on the evening by, amongst others, H.W. Dunmore, J. Short and G.H. Gooderson. Half way through the concert news arrived of the attempted assassination of the Prince of Wales by a young anarchist, Jean-Baptiste Sipido, at the Brussels-North railway station. The *Advertiser* noted with approval that "the whole company at once joined in singing most loyally and heartily 'God Bless the Prince of Wales'."

After nomination, William W. Clowes decided to retire from the Council and withdrew his nomination papers within the allowable period. A further candidate for this election, Rev. William D. Bushell, withdrew after the close of nominations but within the allowable period. Hunt and Batchelor contested the election on a joint 'ticket'.

On 24 September 1902 Local Government Board Order no. 44,414 made minor changes to the boundary of Harrow-on-the-Hill UD with Wealdstone UD. This was the first election following the Order coming into force; no electors were affected by the boundary alteration.

The *Harrow Gazette* incorrectly reported that the number of electors at this election was 1,972. Turnout has been calculated on the basis that the reported number voting (944) is correct.

Two further candidates for this election, John S. Hastings and George F. Shepherd, were nominated but the Returning Officer ruled that their nomination papers were invalid.

The *Harrow Observer* overestimated the number of electors at this election as 2,400. Turnout has been calculated on the basis that the reported number voting (1,050 in the District) is correct. The newspaper said that 511 electors voted at Roxeth Hill and 539 at Greenhill, thereby allowing construction of the following analysis:

A prominent local landowner and benefactor, Mr. Samuel Gardner of 'Oakhurst', Mount Park Road, attempted to broker a 'ticket' of candidates to contest this election. A meeting was held at Gardner's home on 13 March with O'Brien, Pitcairn, Werner, Henderson and Sherwood in attendance. The five candidates were invited to run on the ticket together, but O'Brien declined.

The *Harrow Observer* reported the number of electors as 2,439, but also stated the number voting by polling place, thereby allowing construction of the following analysis:

At close of nominations two further candidates had come forward to fill the fourth seat, namely Richard Elias and John A. Smith (better known as J. Albert Smith, an optician with premises on the High Street). Neither Elias or Smith wished to cause the expense of a contested election, so they agreed to draw lots for the fourth vacancy. Elias won and Smith withdrew his nomination papers within the allowable time.

Both the *Harrow Gazette* and the *Harrow Observer* reported that the number of electors at this election was 3,076. Turnout has been calculated on the basis that the reported number voting (1,012) is correct. The spoilt paper was caused by the "enthusiastic elector giving two votes each for two candidates"; contemporary Returning Officers probably would have allowed the paper as good (single) votes for the two candidates in question.

A seventh candidate for this election, Rev. Lionel Goodrich, withdrew after the close of nominations but within the allowable period.

The *Harrow Observer* reported that the number of electors at this election was 3,375. Turnout has been calculated on the basis that the reported number voting (1,090) is correct.

Reynolds and Poole issued a joint election address.

There were few polling day incidents for the *Harrow Observer* to report: "There were no weighty questions at Harrow which disturbed the voters, and the drizzling rain and cold wind of Monday emphasised the apathy of the electorate.... The most active among the candidates was Mr. T. Charles, who, with the kindly aid of Mr. J.E. Jones' motor car, and the pony cart of his son, Donald, brought many a voter comfortably to the poll despite the inclement weather."

An eleventh candidate for this election, John Daborn, withdrew after the close of nominations but within the allowable period.

The *Harrow Observer* reported that 521 electors voted at Roxeth Hill and 712 at Greenhill, making a district total of 1,233, thereby allowing construction of the following analysis:

Martin, Strickland, O'Brien and Stevens were endorsed by the *Harrow Observer*. The newspaper made no pretence at impartiality and displayed deep hostility, in both its reporting and editorial columns, to the presence of Socialist candidates at the election.

Hawks, Higgins and Steemson were nominees of the local branch of the Independent Labour Party (ILP). Higgins and Steemson were also members of the Bessborough Social Association and supported the Association's policy that provision should be made for a recreation ground on the Bessborough Estate. The Chairman of the Association, Edward G. Bunyan, advised them that the Association was "non-political and unsectarian" and could not, as an organisation, endorse them.

The *Observer's* diarist reported that "one Socialist candidate, who attended the Council chamber during the counting, with regal indifference to custom kept his hat on during the whole time he was in the room. This absolute indifference to custom — I won't say anything more — is I suppose the hallmark of Socialistic upbringing."

Gough and Wildy were the candidates of the local Anti-Socialist Union. There is uncertainty about the precise form of the name of *both* the Union's candidates. The spelling of Wildy's surname appears to be confirmed by the *Minutes* of the Council, the 1912 *Register of Electors* and 1911 *Census* returns; however the *Harrow Observer* persisted throughout its election coverage with the spelling "Wildey". The issues surrounding Gough's name are complex and form the subject of Appendix W (page 215).
