Note: Details of the Parish Meeting have yet to be found. However, the *Hendon and Finchley Times* reported, in its edition of 21 March 1919, that the nine people named above were the elected councillors for Great Stanmore Parish. Therefore it is likely that the Parish Meeting took place on 17 March and probable that the election of the nine was unopposed. No poll was required.

Note: The reason for Felton ceasing to be a member of the Parish Council is uncertain (he attended his last meeting of the Council on 14 March 1921). Possible dates for Darville's co-option are 18 April or 8 August 1921: he attended his first meeting on 6 February 1922. It is not known if Darville was the only candidate.

Note: The Parish Meeting to elect councillors was held on 12 March at the Institute with district councillor (and retiring parish councillor) Cllr. John Bransgrove in the Chair during the election. The *Harrow Observer and Gazette* reported that 120 ratepayers were present.

The voting figures for the unsuccessful candidates, with the exception of Potter, were not reported by either the *Harrow Observer and Gazette* or the *Hendon and Finchley Times*. Armour and Potter tied for the ninth elected place, each receiving 20 votes. The Chairman used a casting vote in favour of Armour. One elector (Mrs. Erlebach) asked for a poll, but the Chairman refused after taking the views of the Meeting into account.

Note: When the agenda item to co-opt a new parish councillor was reached, Cllr. Hammond enquired whether Thomas J. Potter, who had received the highest vote among the unsuccessful candidates at the Parish Meeting, should be considered to fill the vacancy. However Hammond was told that Potter was "not anxious to serve." Cllr. Hewett proposed and Cllr. Chapman seconded that Wood be chosen to fill the vacancy. There were no other nominations.

Note: The Parish Meeting to elect councillors was held on 9 March at the Institute with Mr. Henry Burn in the Chair during the election. The *Harrow Observer and Gazette* reported that bad weather was responsible for a poor turnout as only five people, apart from retiring members of the Council, were present.

The *Hendon Times and Guardian* reported on events as follows: "It was hard to realise that there was an election in Great Stanmore. In place of the lively scenes that were to be witnessed in the old days, a deathly silence hung over the village. Only 15 residents attended the meeting, and of that number eight were retiring members of the Council."
