Note: The first Parish Meeting to elect councillors was held on 4 December at the Edgware Board Schools with Mr. Charles E.C. Prichard in the Chair during the election. A poll was not demanded.

The voting figures shown above are those recorded in the *Minutes* and are therefore assumed to be accurate. Both the *Middlesex Courier* and the *Hendon and Finchley Times* reported that Welch received 6 votes and Tootell 10 votes. Additionally, the report in the *Hendon and Finchley Times* stated that Allpress received 15 votes.

Note: The Parish Meeting to elect councillors was held on 9 March. The *Hendon and Finchley Times* reported that "the attendance was very small," and did not report the venue of the meeting, who acted as Chairman or the result of the show of hands. A poll was demanded and resulted in the election of Perry instead of Mann.

The result of the poll indicates that the turnout was at least 13.5%.

Note: The Parish Meeting to elect councillors was held on 18 March at "the schools". The *Hendon and Finchley Times* did not give the name of the person who acted as Chairman, but reported that a Mr. Russell was also a nominated candidate but later withdrew his name. The six shown above were elected by a show of hands, but the names of any other candidates and the voting figures were not given. For reasons that are unclear Mann demanded a poll (despite being successful) but received no support.

Note: The Parish Meeting to elect councillors was held on 6 March in the Girls' School Room with Rev. Hubert H. Phelps in the Chair during the election. A poll was not demanded.

The Clerk erroneously recorded Allen's name in the *Minutes* as 'Frear Allen'. 'Frederick Allen' is the only male elector with that surname in both the Edgware and Little Stanmore sections of the *Register of Electors*.

Note: Shortly after his election Dolling wrote to the Clerk of the Council stating that he had "no intention of acting as a councillor for the parish." Cllr. Mann proposed and Cllr. Cribb seconded that Pollard be chosen to fill the vacancy. There were no other nominations.

Note: The Parish Meeting to elect councillors was held on 5 March in the Girls' School Room with retiring parish councillor Cllr. Frederick J. Allpress in the Chair during the election. Nomination papers submitted in the names of Allpress and Henry Johnson were withdrawn.

The Returning Officer, F.J. Seabrook, took the view that the Parish Meeting was potentially invalid. The Parish Councillors Order (14 January 1901) and the Local Elections: Alteration of Dates Order (1901) specified that Parish Meetings called for the purpose of electing parish councillors should be held on 4 March. An application was made to the Middlesex County Council and a Special Order, giving retrospective validity to the Meeting, granted.

The *Minutes* record that 17 parochial electors were present, although in the estimation of the *Hendon and Finchley Times* 20 to 30 ratepayers attended. A nomination paper submitted in the name of Henry Cheeld was withdrawn.

Note: The Parish Meeting to elect councillors was held on 17 March in the Girls' School Room with Mr. Henry K. Judd in the Chair during the election. The *Minutes* record that 23 parochial electors were present.

Upon the show of hands Sears and Scott tied for sixth elected place with 12 votes each. The Chairman took a fresh show of hands in respect of the sixth seat with the result that Sears received 13 votes and Scott 6 votes. A poll was demanded by a Mr. R.J. Richardson and received support from retiring parish councillor Cllr. George R. Mann, whereupon the Chairman informed the meeting that for a poll to be granted the request must receive the support of five parochial electors or one-third of those present, whichever figure was the lowest.

At this point Cliff stated that if Wilson retired his nomination and did not proceed to the poll he [Cliff] would do the same, thereby avoiding the expense of a poll. Wilson agreed to Cliff's suggestion and the two received the thanks of the Chairman for their action.

Note: The 1916 election was postponed because of the First World War. All six members of Edgware Parish Council continued as Councillors until the 1919 election, unless a casual vacancy was caused by death, resignation or disqualification. The following vacancies occurred during this period and were filled by the existing practice of co-option:

Note: Scott was disqualified under the terms of the Local Government Act 1894, section 46, sub-section 7, for his failure, throughout a period of six consecutive months, to attend any meetings of the Council.
