Note: The nomination papers of Ellement and Hogg were the only ones received by the Returning Officer. Under the terms of the Local Government Act 1894, section 56 of the Municipal Corporations Act 1882 applied: if at an ordinary election any vacancies were not filled by election, the required number of retiring councillors would, if willing, continue to hold office, with those highest in the poll at the previous election having preference. Consequently, Eck was deemed to be re-elected and was co-opted on to the Council. Woodbridge declined to continue in office; Skilbeck was co-opted in his place.

The newspaper additionally reported that Ellement encouraged his supporters to use a second vote for Couper.

Eck, Hogg and Arnold sought election on a joint 'ticket'.

Note: The 1916 election was postponed because of the First World War. All five members continued to serve as Councillors until the 1919 election, unless a casual vacancy was caused by death, resignation or disqualification. The following vacancy for Pinner occurred and was filled by co-option.
