

## Appendix H

### PARLIAMENTARY ELECTIONS: BOUNDARIES AND POLLING DATES

Following the Redistribution of Seats Act 1885, Parliamentary boundaries were redrawn in time for the 1885 General Election. The whole of the current area of the modern London Borough of Harrow was contained within the **Middlesex, Harrow** division. This division, incorporating a large part of the County of Middlesex, existed until the 1918 General Election and comprised, according to the 1890 *Register of Electors*, the following polling districts:

By 1891 the Harrow polling district had been reorganised in to four polling districts as follows:

a.	Harrow (Urban)	The District of the Harrow Local Board in the Parish of Harrow-on-the-Hill
b.	Pinner	The Hamlet of Pinner
c.	Sudbury	The Ecclesiastical District of St. John, Wembley, in the Parish of Harrow-on-the-Hill
d.	Wealdstone	Those parts of the Parish of Harrow-on-the-Hill not included in the Harrow (Urban) and Sudbury polling districts

As a result of the Representation of the People Act 1918, there was a wholesale revision of Parliamentary boundaries. The Harrow area was now covered by parts of two constituencies, the boundaries of which remained in force from the 1918 General Election up to (but not including) the 1945 General Election:

The **Middlesex, Harrow** division, as constituted in 1918, contained the Urban Districts of:

- Harrow-on-the-Hill [Abolished on 1 April 1934 and became part of Harrow UD.]
- Wealdstone [Abolished on 1 April 1934 and became part of Harrow UD.]
- Greenford [Abolished in October 1926 and became part of Ealing MB.]
- Hanwell [Abolished in October 1926 and became part of Ealing MB.]
- Wembley [Became Wembley MB in 1937.]

The **Middlesex, Hendon** division, as constituted in 1918, contained the Rural District of:

- Hendon [Edgware Parish became part of Hendon UD on 1 April 1931. The remainder was abolished on 1 April 1934 and became part of Harrow UD.]

and the Urban Districts of:

- Hendon [Enlarged on 1 April 1931 by the addition of Edgware Parish. Became Hendon MB in 1932.]
- Kingsbury [Abolished on 1 April 1934 and became part of Wembley UD. Electors from this area continued to vote in the Hendon division.]

When the South Harrow Recreation Ground and Mount Park areas of Northolt Parish of Uxbridge RD were transferred to Harrow-on-the-Hill UD on 1 October 1928 the electors concerned continued to vote in the **Middlesex, Uxbridge** division.

Between 1885 and 1910 polling for a Parliamentary General Election did not take place on a single day throughout the country, but typically over a two to three week period. The dates in square brackets show the actual date of polling in the Harrow division, or, in the case of an unopposed return, the nomination date.

In Appendix J which follows, the voting figures for the Harrow division before 1918 are based on those in F.W.S. Craig, *British Parliamentary Election Results, 1885-1918*, Macmillan, London and Basingstoke, 1974.

The voting figures for the Harrow and Hendon divisions from 1918 are based on those in F.W.S. Craig, *British Parliamentary Election Results, 1918-1949*, (rev. ed.), Macmillan, London and Basingstoke, 1977. (Results for the Middlesex, Uxbridge division can be found on page 429.)
