MIDDLESEX COUNTY COUNCIL ELECTIONS: BOUNDARIES AND POLLING DATES

The Local Government Act 1888 established county councils in England, each consisting of councillors and aldermen. The first elections to Middlesex County Council took place in January 1889. At that time the current area of the modern London Borough of Harrow was contained within three electoral divisions, each returning one councillor, as follows:

Electoral Division	Comprising
Harrow-on-the-Hill	That part of the Parish of Harrow-on-the-Hill known as the Urban Sanitary District (not comprised in the Sudbury polling place)
Harrow	That part of the Parish of Harrow-on-the-Hill known as the Rural Sanitary District (not comprised in the Sudbury polling place) That part of the Parish of Harrow-on-the-Hill known as Sudbury
Pinner	The Hamlet of Pinner The Parish of Edgware The Parish of Great Stanmore The Parish of Little Stanmore The Parish of Kingsbury [In 1894 became the Kingsbury ward of Wembley UD; in 1900 became the Urban District of Kingsbury.]

The area that would later become the Parish of Harrow Weald was part of the Harrow electoral division. This resulted in Pinner electoral division comprising two detached parts.

On 1 October 1895 the boundary between the Harrow-on-the-Hill and Wealdstone Urban Districts was altered. To take this into account, the boundaries of the MCC electoral divisions were revised at the next county election in 1898. On 24 September 1902 the boundaries between Harrow-on-the-Hill UD, Wealdstone UD and Hendon RD were modified. Taking these new boundaries into account, a change to the MCC electoral division boundaries took place at the next county election in 1904.

There was a general boundary revision in 1907 to leave the three electoral divisions serving the Harrow area as follows:

Electoral Division	Comprising
Harrow-on-the-Hill	The Urban District of Harrow-on-the-Hill
Wembley	The Urban District of Wealdstone The Urban District of Kingsbury The Urban District of Wembley
Pinner	The Rural District of Hendon [i.e. the parishes of Pinner, Harrow Weald, Great Stanmore, Little Stanmore and Edgware.]

A further general boundary revision in 1922 meant that Wealdstone became an electoral division in its own right, to leave the electoral divisions for the Harrow area as follows:

Electoral Division	Comprising
Harrow-on-the-Hill	The Urban District of Harrow-on-the-Hill
Wealdstone	The Urban District of Wealdstone
Pinner	The Rural District of Hendon [i.e. the parishes of Pinner, Harrow Weald, Great Stanmore, Little Stanmore and Edgware.]

When the South Harrow Recreation Ground and Mount Park areas of Northolt Parish of Uxbridge RD were transferred to Harrow-on-the-Hill UD on 1 October 1928, the electors concerned continued to vote in either the **Hayes** electoral division (parts of Westwood Avenue, Wood End Avenue, Mount Park Road and South Hill Avenue) or the **Ealing North-West** electoral division (parts of Cavendish Avenue and Wood End Road).

When Edgware parish was transferred to Hendon UD on 1 April 1931, an election of MCC councillors had taken place just a few weeks earlier, with Edgware part of the Pinner electoral division. At the 1934 election division boundaries were altered so that the Pinner electoral division excluded Edgware (which now formed a part of the **Hendon North** electoral division).
