

Appendix K

PARLIAMENTARY AND GLC ELECTIONS IN HARROW, 1964-1977

This Appendix sets out results for Parliamentary and Greater London Council (GLC) Elections. The format is similar to the main results tables, including the inclusion of a column showing the % share of the vote achieved by each candidate. A cross (+) before the name of a candidate in 1964 indicates a member of the previous (1959-1964) Parliament. An asterisk (*) indicates a forfeited deposit. Turnout is based on the number of valid votes cast.

Between 1964 and 1970 elections to the GLC were conducted on the basis of the whole of the London Borough of Harrow forming one large electoral division, returning three Councillors. (For these elections turnout is based on the number of ballot papers issued.) From 1973 single-member seats were introduced; in Harrow the seats had the same boundaries as the existing Parliamentary constituencies.

Following an Order made by the County Court dated 17 April, a recount was held on 20 April. Large discrepancies were found which reduced the total votes as first announced by 25,142, and increased the total ballot papers by 97 to 60,042. F.W.S. Craig, in his booklet *Greater London Votes: 1. The Greater London Council 1964-1970*, records the total ballot papers as 60,074.
