INVALID LIBERAL DEMOCRAT NOMINATIONS, 2002

All the following nominations were described, on the 'Statements as to Persons Nominated', issued by the Returning Officer, as breaking rule 4A(1) of the Local Elections (Principal Areas) Rules 1986.

A ruling by Judge Scott Baker in the High Court on 11 April 2002 confirmed the 5 April 2002 decision of Returning Officer Gerald Balabanoff that the nomination papers of 60 of the 63 Liberal Democrat candidates for the May 2002 borough election were invalid. This was because the description of the party given on the nomination papers ("Liberal Democrat Focus Team") did not match the description ("Liberal Democrats") on the previously supplied Political Party Registration Certificate. The need to supply a Certificate is a requirement of the Political Parties, Elections and Referendums Act 2000.
